

High-Build Poly-Urethane 45 μ m Coatings Warranty Of Durability

DATE : 2006. 4.15

This Warranty Agreement is made between HYUNDAI HYSCO CO., LTD(hereafter called "HYSCO") and a PANEL maker (hereafter called "Purchaser").

HYSCO warrants to Purchaser that the surface coated with High-Build Poly-Urethane 45 μ m on Galvanized Iron steel coils by HYSCO will meet the following exterior durability standards; for a period of twenty (20) years from the date of the shipment from the Republic of Korea.

- A. will not chalk in excess of the ASTM-D-659 Number 6 rating determined by the procedure outlined in ASTM-D-659 ;
- B. will not fade more than the number of 8E(Hunter) units as determined by the procedure outlined in ASTM-D-2244 / EN13523-22 and based on the color measurement made on clean surfaces free of all dirt, chalk, oxidized film, oil, grease or other foreign contaminants; provided, however, that fading or color change may not be uniform between surfaces not equally exposed; and
- C. will not crack, check, peel, flake or chip to an extent that is apparent on ordinary outdoor visual observation; provided, however, that any cracks, breaks or other defects in the Paint occurring during installing or fabrication of the Products shall not be covered by this Warranty.

THIS WARRANTY SHALL BE SUBJECT TO STIPULATIONS AND CONDITIONS HEREINAFTER SET FORTH :

- 1. The Performance of this Warranty is limited only to the Products which are developed upon deliberation between HYSCO and the Purchaser ;
- 2. The exclusive and sole remedy under this Warranty shall be, at the sole discretion of HYSCO to (i) repaint the Products ; or (ii) provide free of charge, replacements (but not installation) for the Product with defective Paint ; or (iii) reimburse the cost of such repainting or replacement by the PURCHASER, provided, however, that the amount of such reimbursement shall in no event exceed the original purchase price of the product ;
- 3. Any repainted or replaced Products shall be subject to this Warranty only for the unexpired period of Warranty applicable to the original products ;
- 4. HYSCO shall not in any event be liable for the cost of labor expended by others on any Products with defective paint unless otherwise specifically authorized in writing by HYSCO prior to the performance of any such works ;
- 5. HYSCO extends this Warranty solely to the PURCHASER. This Warranty is non-transferable and non-assignable, and neither the customer nor the Customer nor panel maker shall permit or authorized their employees, agents, representatives or customers to claim, represent or imply that the performance warranties extend to or are available to the Customer.
- 6. HYSCO reserves the right to terminate this Warranty at any time without a written notice. thereof, except with respect to orders which it has already accepted subject to this Warranty ;
- 7. HYSCO shall be given a reasonable opportunity to inspect the Products claimed to be defective, work method, machines and means of shipment.
- 8. The PURCHASER must notify HYSCO in writing and Internet (<http://hysco.e-sang.net>) within thirty(30) days after a defects is called to the attention of the PURCHASER, specifying the HYSCO order number, coil number, invoice number, date of shipment and date of installation of any products upon which a claim is made hereunder ;
- 9. Fade or change in color may not be uniform if the surfaces are not equally exposed the sun radiation and elements. The Warranty will not cover or extend to
 - a. The areas of high salt concentration such as adjacent to the seashore
 - b. The areas such as adjacent to the factory
 - c. severe air pollutant areas
- 10. This Warranty will not extend or cover
 - a. Damages to the Products or the Paint occasioned, directly or indirectly, by moisture or other contaminations detrimental to the Product or the Paint because of improper storage, handling, processing or forming of the Products prior to installation.
 - b. Water damage to the Products or the paint due, directly or indirectly, to condensation caused by improper storage, handling, processing, forming or packaging of the Products prior to installation.
 - c. Damages to the Products or the paint caused by improper storage, handling, processing, forming or packaging of the Products prior to installation.
 - d. Damages by a natural disaster, war, fire and exterior impact etc.
